1. Agree to be set up by 9:30 a.m. on Saturday and remain set up until 4:00 p.m. on Saturday.
2. Agree to have displays dismantled and to vacate the premises by 5:00 p.m. on Saturday.
3. Agree to limit sales to items and not conduct a raffle or gambling of any kind.
4. Refrain from selling concession food of any kind.
5. All items at your table must be handmade; no manufactured goods (Avon, Scentsy, etc.)
6. Agree to the terms of this contract.

In Addition: The undersigned agrees they shall indemnify and hold harmless The Catholic Community of St. John and Blessed Sacrament for any loss whatsoever, claimed by the undersigned, its agents or employees, arising out of the undersigned's participation in the craft show. The undersigned acknowledges the Craft Show committee reserves the right to remove any item deemed offensive.
